Located at the bottom of this private and secure road occupying what is unquestionably the most desirable plot in the area the attention to detail externally and internally is impressive.



























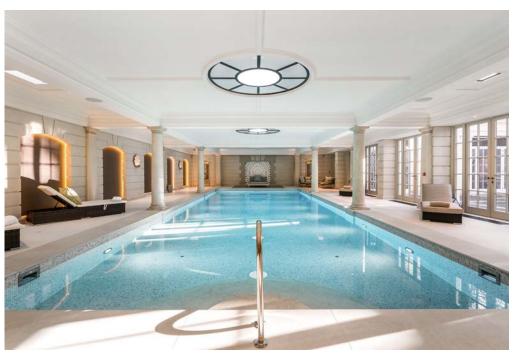
































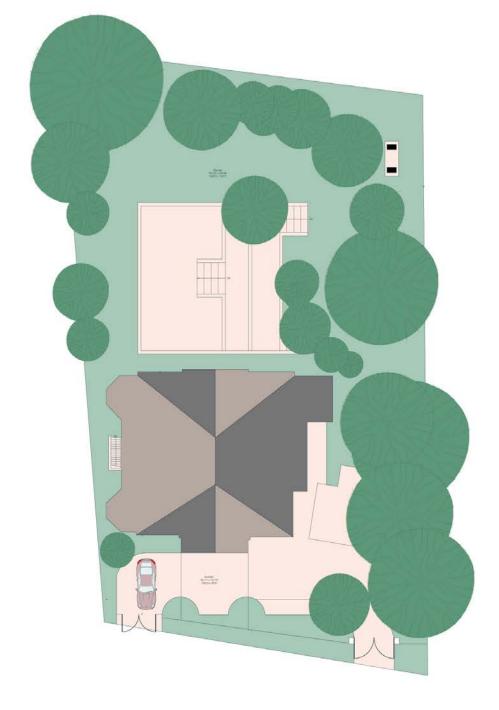
